Driven by the pursuit of greater efficiency and stability in concentrations, we have optimized and enhanced the quality standards set from the very beginning of our commercial journey.

The idea to build a new plant arose from the need to expand both the packaging and storage areas while also increasing commercialization. This ensures top-quality products that fully comply with European and national regulations.

We designed a semi-automated plant almost from scratch, with meticulous attention to detail. Our primary goal was to create a modern facility equipped with the latest protection systems and technologies to ensure worker safety and respect the environment.

Some of these measures include continuous air renewal systems, mechanisms to prevent gas emissions, safety tanks for possible spill containment, semi-automated load handling systems, and a selective waste collection system.





The plant is divided into 4 areas: offices, the packaging area, the warehouse for pre-formulated products, and a large outdoor area where the raw material storage tanks are located.

Thanks to the efforts of the **Tashia®** development team and other industry professionals, we have met all expectations. We are now looking to expand our operations to reliably handle exports, produce new products adapted to market evolution, and improve water treatment systems, a field in which **Tashia®** continues to be a pioneer.

Water, what we live for


